## 2016/033P Public Rights Of Way

- **Definitive Map Project** Cllr. Blackburn has compared the published Ordnance Survey map with Parish records and noted that 6 footpaths are not recorded as PROWs. He is liaising with Anthony Francis-Jones who is also comparing the OS map with his records. Cllr Blackburn also noted that he has heard that TWC are currently digitising their maps but no official notification of this project has been received.

### 2016/034P HHLDO Consultation

The consensus of the meeting was that losing the existing consultation process means that local knowledge on applications will be lost.
